Documentation supporting the applicant's position as a Contractor is required. Please ensure the documentation below is also provided at the time of application:

If the vehicle is registered to the Company

- A valid MPI Vehicle Registration for each vehicle/trailer that requires a permit; and
- Proof of ownership (e.g. Annual Return of Information); or
- If you are not the owner of the Company and are applying on behalf of the Company, a letterhead from the company stating the applicant can purchase the permit on behalf of the company. In this case the permit would be sold to whomever is providing payment.

If the vehicle is registered to you

- A valid MPI Vehicle Registration or copy thereof for each vehicle/trailer that requires a permit; and
- If the vehicle is registered in your name and not a company name, you will need to provide a letter on company letterhead stating you are providing home repair services and the vehicle is being utilized for contractor services within the City of Winnipeg; or
- Other evidence that the vehicle is being used for the provision of contractor services such as Business Registration papers.

Terms and Conditions

Definitions

- 1. The following terms shall have the following respective meanings:
 - (a) Agreement means this agreement;
 - (b) **Applicant** means the applicant identified on this application;
 - (c) **Application** means this application;
 - (d) By-law means the Winnipeg Parking By-Law 86/2016, the Municipal By-Law Enforcement Act Enabling By-Law 59/2016, the Winter Parking Ban By-Law No. 76/2011, as applicable, and any replacement By-laws, as the case may be;
 - (e) **City** means the City of Winnipeg;
 - (f) Contractor means an individual or corporation in the business of providing a carpentry, plumbing, gas fitting, roofing, electrical or other contractor service relating to the construction, renovation, repair, landscaping or maintenance of real property.
 - (g) **Permit** means any parking permit issued pursuant to this Agreement;
 - (h) **Vehicle** means the vehicle identified on the Application and any additional vehicle(s) linked with the Permit, where allowed by the permit type;

- (i) **Virtual Permit** means a Permit which is identified by the Vehicle's licence plate and which is not displayed within the Vehicle;
- (j) **WPA** means the City of Winnipeg Parking Authority.
- 2. This Application will be rejected and the Vehicle owner may be subject to penalty as stipulated under the By-law if at the time this Application is submitted:
 - (a) the Vehicle is registered with Lay-up Coverage through Manitoba Public Insurance;
 - (b) the City is entitled to take collection action for outstanding fines or charges associated with the Applicant or the Vehicle;
 - (c) the Applicant fails to provide any documentation requested by the WPA in connection with this Application; or
- 3. The WPA is not responsible for any loss or damage whatsoever resulting from lost or delayed correspondence sent via standard or registered lettermail delivery service.
- 4. By providing the WPA with personal information the Applicant consents to the WPA securely storing such information, and consents to the use of it by the WPA to contact the Applicant and/or verify the Applicant's identity.
- 5. Approval of this Application by the WPA constitutes a binding agreement between the Applicant and the WPA under the following conditions:

Applicant Obligations

- 5.1 The Applicant is responsible for compliance with the terms of the Agreement, including compliance of the Vehicle.
- 5.2 The Applicant shall park courteously and shall comply with all regulations, instructions, benefits and penalties, as may be applied by the City in accordance with its By-Laws, including but not limited to ticketing and towing of the Vehicle.
- 5.3 The Applicant shall notify the WPA of any change of licence plate number, contact address, or vehicle registration by completing the Licence Plate Registration Form located on the WPA's website and submitting same to the WPA. Failure to do so constitutes a violation of this Agreement and the Vehicle owner may be subject to penalty pursuant to the By-Law, including but not limited to revocation of the Permit and ticketing and/or towing of the Vehicle.
- 5.4 The Permit is non-transferable between individuals or vehicles and is valid for use by the Applicant for the Vehicle and registered trailers only. Limitation of Liability
- 5.5 The City and the WPA shall not be liable for injury to or loss suffered by any persons using the parking facility or parking stall specified above, or for loss of or damage to vehicles and their contents. The City shall be free from any and all liability or claim arising due to any injury to employees of the City, third persons, or members of the public, or their property, caused by any act or omission of the Applicant and which is attributable to the Applicant's use of the specified parking facility and/or parking stall.

Termination

- 6.1 The Applicant may terminate this Agreement by providing one full calendar month's written notice to the WPA by filling out the Permit Cancellation Form located on the WPA's website and delivering it to the WPA or submitting it by email to <u>wpapermits@winnipeg.ca</u> or by fax to 204-986-5155. The Applicant shall provide any such notice to the WPA on or before the 1st day of the month for cancellation to be effective the last day of that month. In the event that any such notice is provided to the WPA on the 2nd of the month or later, the notice period shall be deemed to begin on the 1st day of the following month and cancellation will be effective on the last day of the month following the notice period. In such an event, the Applicant shall be responsible for additional charges.
- 6.2 The WPA may terminate or alter the terms of this Agreement by providing one full calendar month's written notice of alteration or termination to the Applicant. Any such alteration or termination shall be at the sole discretion of the WPA.
- 6.3 The WPA may revoke, suspend, or cancel the Permit without notice at any time for any violation of the terms of this Agreement, for non-payment or returned payment, or for any illegal activities by the Applicant. In the event that the Permit is revoked, suspended, or cancelled by the WPA, the Applicant may be subject to penalty, including but not limited to ticketing, towing, and administrative fees, and the Applicant may be unable to reapply for a new permit for the period set out in the By-Law. The Applicant shall be liable for all outstanding amounts owing under this Agreement, including late/NSF charges as set out in the City of Winnipeg Fees and Charges By-law No. 196/2008 and any fees incurred due to the Applicant's failure to provide one full calendar month's notice of termination to the WPA.

Permit-Specific Terms and Conditions

7. Any Virtual Permit issued pursuant to this Agreement:

- (a) will be activated for use after the Application has been approved by the WPA. The Applicant must ensure at all times that the licence plate(s) associated with the Virtual Permit is displayed on the Vehicle(s). Failure to do so will result in the Vehicle being subject to penalty under the By-Law, including but not limited to ticketing and/or towing of the Vehicle.
- (b) is a non-refundable permit.
- (c) will allow the Vehicle(s) to be parked in excess of the posted time restriction on residential streets. It does not exempt the Vehicle from obeying all other posted traffic and parking regulations, including paying at metered locations and obeying posted time limits. This includes a prohibition against parking on the same block for more than a total of 48 consecutive hours.
- (d) will allow the Vehicle(s) to be parked in an alley but does not allow the vehicle(s) to obstruct traffic flow.
- (e) will cover both the truck and attached trailer registered to the permit. The permit fee includes registration of one trailer. Up to two additional trailers may be registered for an additional fee.

By signing below, the Applicant agrees that they have fully read and understood all terms and conditions outlined above, and the Applicant accepts and agrees to be bound by the said terms and conditions in their entirety.
