THE CITY OF WINNIPEG

TRAFFIC BY-LAW NO. 1573/77

A By-law of THE CITY OF WINNIPEG concerning the Regulation of Traffic.

The Council of the City of Winnipeg, in Council enacts as follows:

- 1. This By-law may be referred to as the "City of Winnipeg Traffic By-law".
- 2. (1) Unless otherwise expressly provided or unless the context otherwise requires, words and expressions in this by-law have the same meaning as the same words and expressions in *The Highway Traffic Act* of the Province of Manitoba and in Manitoba Regulation 575/88, being the Vehicle Weights and Dimensions on Classes of Highways Regulation passed pursuant thereto.
 - (2) In this By-law amended 8162/2002

"Chief of Police" means the Chief of Police of The City of Winnipeg or such person as may be authorized by the said Chief of Police to exercise some or all of the powers vested in him/her by this by-law.

"**curb**" means the lateral line of a roadway.

"**Director"** means the Director of Public Works or such other person as may be authorized by the said Director to exercise some or all of the powers vested in him/her by this by-law.

"driver" means a person who drives or is in actual physical control of a vehicle and includes any body corporate in respect of vehicles driven by its officers, employees, or agents in the course of their employment, and the expressions "drive" and "driving" have a corresponding meaning.

"driver transfer point" means a point of transfer within the City such as a trucking terminal and as so identified and authorized by the Director as may be required from time to time, to enable a change of truck drivers for a trip originating from outside the City and destined to a point within the City other than the point of transfer.

"garage sale" means the display and sale of a collection of used goods from residential premises.

"Holiday" or **"Public Holiday"** includes New Year's Day, Good Friday, Victoria Day, Remembrance Day, the day set aside to celebrate the Queen's Birthday, Canada Day, Civic Holiday, Labour Day, Thanksgiving Day, Christmas Day and Boxing Day or any other day proclaimed as a holiday.

"parade" means any procession or body of pedestrians excepting members of Her Majesty's Armed Forces, numbering more than thirty (30) standing, marching, or walking anywhere on a street, or any group of vehicles except a funeral procession or vehicles of Her Majesty's Armed Forces, numbering ten (10) or more stopped or moving anywhere on a street.

"**private approach**" means that portion of a sidewalk and/or boulevard lawfully improved or designed for the passage of vehicular traffic.

"Regional Street" means a street designated as such by Council on May 2, 1973 and as may be amended from time to time.

"RTAC truck" means a truck, a truck and pony trailer combination, a truck and full trailer combination, a truck and semi-trailer combination, an A, B, or C-Train, which conforms to the criteria set out in Sections 9, 13, 14, 15, 16, 18, 19, 20, 21, 23, 25, 28, and 30 of Manitoba Regulation 575/88.

"truck" means a motor vehicle or semi-trailer truck, that is constructed or adapted to carry goods, wares and merchandise, freight or commodities, but not passengers or baggage, and that has more than four tires.

"truck tractor" means a motor vehicle designed and used primarily for towing other vehicles, and not so constructed as to carry a load other than the driver thereof and part of the weight of any vehicle so towed including the load thereon, and that has more than four tires.

PROOF OF SCHEDULES

3. The schedules to this by-law are part of the by-law and shall be identified by the signature of the City Clerk of the City of Winnipeg.

CAUSING OR PERMITTING OFFENCE

4. Any person who causes or permits an offence against this by-law is guilty of an offence.

SOLICITING RIDES PROHIBITED FROM ROADWAY

5. No person shall occupy a roadway for the purpose of soliciting a ride from the driver of a vehicle.

COASTERS, SKATEBOARDS, ETC., PROHIBITED ON ROADWAYS

6. No person shall ride upon or use any coaster, skateboard, sleigh, skis, skates, toy vehicles, or similar devices on a roadway.

IN-LINE SKATING

6.1 Notwithstanding the provisions of Section 6 hereof, the use of roller blades commonly referred to as in-line skates is permitted:

- (a) On roadways designated by resolution of the Standing Policy Committee on Public Works as Bicycle Routes during the period when vehicular traffic is restricted to local access on said roadways; and, *amended 8162/2002*
- (b) On roadways in City of Winnipeg parks, except where such use is expressly prohibited by traffic control device. *added 5991/92 (entire subsection 6.1)*

PROHIBITION OF SKATEBOARDS ON DESIGNATED SIDEWALKS

6.2 No person shall ride upon or use a skateboard on a sidewalk where there is placed a traffic control device prohibiting such use of the sidewalk. *amended 7883/2001*

ARREST OF A PEDESTRIAN

7. Where a peace officer has reasonable grounds for believing that a pedestrian has committed or is committing a breach of those provisions of a by-law that relate to pedestrian traffic, he may require the pedestrian to stop and there and then to state correctly his name and address, and to prove his identity to the satisfaction of the peace officer.

8. If a pedestrian refuses or fails to stop and state correctly his name and address or so to prove his identity when so required, the peace officer may arrest him without warrant.

PARADES

9. No person shall hold, take part in, or be a member of a parade unless

- (a) the parade is under the direction or control of a marshal or organizer, and
- (b) the parade has been duly permitted by the Chief of Police.

10. A person desiring to hold a parade shall apply in writing to the Chief of Police for a permit therefore not less than forty-eight hours before the time set for the commencement of the parade, and shall when making his request, specify the nature of the parade, the day and hour at which it is to be held, the places of formation and dispersal, the exact route to be followed, the estimated length of time for the parade to pass a given point and pay such sums of money as the Chief of Police shall require for the purpose of publishing due notice of the parade and such diversion of traffic as he shall deem necessary as a result thereof.

11. (1) The Chief of Police must issue a parade permit where

- (a) the applicant has complied with section 10;
- (b) the proposed parade would not violate a law, regulation or by-law;
- (c) adequate security and traffic control can reasonably be provided by the Winnipeg Police Service or the applicant is able to offer a reasonable alternative; or
- (d) the time, date or route of the proposed parade

- (i) is unlikely to unduly disrupt traffic along the parade route;
- (ii) is unlikely to result in conflicts with other events or parades taking place; or
- (iii) does not poses undue security or public safety concerns.
- (2) Where the Chief of Police refuses to issue a parade permit, he or she must propose a reasonable alternative date, time or route for the parade.
- (3) The Chief of Police may issue a parade permit subject to conditions that will ensure that the parade meets the criteria set out in subsection (1), and a failure to comply with any conditions imposed invalidates the permit.
- (4) The Chief of Police may withdraw the permit prior to or during the parade where information unknown to the Chief when issuing the permit indicates that the parade will fail to meet the criteria set out in subsection (1), and no person may take part in or continue to take part in a parade where the parade permit has been withdrawn.

MOVEMENT PROHIBITED THROUGH PARADES

12. Unless so directed by a peace officer, no person other than the driver of an ambulance travelling in an emergency or a police department vehicle or a fire department vehicle shall drive through a parade.

13. While a parade is in motion, pedestrians shall not walk through a parade.

INSTALLATION AND MAINTENANCE OF TRAFFIC CONTROL DEVICES

14. The Director shall place and maintain or cause to be placed and maintained all traffic control devices authorized by Council.

TEMPORARY TRAFFIC CONTROL DEVICES

15. The Director shall place and maintain or cause to be placed and maintained temporary traffic control devices to prohibit or regulate traffic in an emergency or for the purposes of carrying out any authorized work on the street including street cleaning and snow removal operations or as authorized by the Chief of Police to insure orderly movement of traffic, to prevent injury or damage to persons or property, or to permit action in any emergency.

- 16. (1) There is hereby adopted as part of this by-law the documents entitled *Manual of Temporary Traffic Control in Work Areas on City Streets, 2008 Edition* and identified by the signature of the City Clerk of the City of Winnipeg. *amended 8167/2002; 47/2008*
 - (2) Any person undertaking authorized work of any form within a street or in any way interfering with or obstructing the normal use of a street shall place and maintain temporary traffic control devices as prescribed in the *Manual of Temporary Traffic Control in Work Areas on City Streets, 2008 Edition*, or as directed by the Director. *amended 8167/2002; 47/2008*

SPRING WEIGHT RESTRICTIONS

- 17. (1) The Director may restrict the maximum weight of vehicles operated on those streets that do not have concrete pavement to the extent and for such period of time as is reasonably required to protect the streets from damage and deterioration during spring thaw conditions.
 - (2) Where the Director restricts the maximum weight of vehicles on streets pursuant to subsection (1), the Director must cause to be placed such traffic control devices as are necessary to reasonably inform the public of the restrictions and, at least one week prior to the weight restriction coming into effect, must publish in a newspaper having a general circulation in the city a notice setting out
 - (a) a description or list of the streets affected by the weight restriction;
 - (b) the maximum weight permitted on the streets identified; and
 - (c) the period of time during which the weight restrictions are in effect.

(3) No person may operate a vehicle on a street in contravention of a restriction made by the Director pursuant to subsection (1).Director shall place and maintain or cause to be placed and maintained traffic control devices to limit the weights of vehicles operated upon streets that do not have concrete pavements. The weight limitation referred to herein shall be imposed during the period March 23 to May 31, both inclusive, of each year, unless the Director declares otherwise. *amended 86/2005*

COMPLIANCE WITH TEMPORARY TRAFFIC CONTROL DEVICES

18. No person shall drive a vehicle on any street or portion of street that is barricaded or otherwise indicated as being closed to vehicular traffic.

19. Unless otherwise directed by a peace officer, pedestrians and drivers shall obey the direction, instruction, limitation, restriction, or prohibition of any applicable traffic sign, traffic control signal, marking, barrier, or device placed or maintained by the Director for the purpose of regulating or prohibiting traffic, for highway construction, repair, maintenance, painting or any emergency.

REPARKING IN UNMETERED AREAS

20. For the purpose of any provisions of this by-law restricting unmetered parking to definite time limits, unless a vehicle is moved through the nearest intersection, it shall be deemed to have remained stationary.

WHERE STOPPING, STANDING, PARKING PROHIBITED

21. Except when necessary to comply with the directions of a peace officer or traffic control device, no person shall stop, stand or park a vehicle:

- (1) on a sidewalk;
- (2) in front of a driveway;
- (3) within an intersection or within three metres thereof;
- (4) within three metres from the point on the curb or edge of the roadway immediately opposite a fire hydrant;
- (5) on a crosswalk;

- (7) in such manner that constitutes an obstruction or hazard on the highway;
- (8) on the roadway side of a vehicle stopped or parked at the edge or curb of a street;
- (9) except when a traffic authority otherwise permits, or on a one-way roadway when not forbidden by the traffic authority, a driver shall not stop, stand or park a vehicle other than on the right side of a highway and with the right-hand wheels parallel to that side, and where there is a curb, within 450 millimetres of the curb. *amended 7580/2000*

POLICE MARKING PARKED VEHICLES

22. A Peace Officer for the purpose of enforcing the provisions of this by-law, or of any other by-law or regulation of the City of Winnipeg respecting the parking of vehicles, may make or place a mark upon a vehicle which is parked upon a street.

23. No person shall remove, alter, obliterate or deface a mark made or placed upon a vehicle by a Peace Officer as provided in Section (22) until the vehicle has been moved through the nearest intersection.

REMOVAL OF TRAFFIC TICKET FROM A VEHICLE

24. No person, other than the person having charge of a vehicle, shall remove from the vehicle a ticket or notice placed thereon by a peace officer to notify the owner or person in charge of the vehicle of an alleged contravention of a provision of this by-law respecting the stopping or parking of vehicles.

STOPPING AND PARKING PROVISIONS NOT EXCLUSIVE

25. The provisions of this by-law dealing with restrictions on stopping or parking shall not relieve any person from the duty to observe other and more restrictive provisions, prohibiting or limiting the stopping or parking of vehicles in specified places or at specified times.

COMPLIANCE WITH SIGNS REGULATING PARKING AND STOPPING

26. (a) Where a traffic control device is placed or maintained to prohibit the stopping or parking of vehicles at any time or during the hours stated on the sign on the street or any portion thereof, no person shall stop or park a vehicle or cause or permit a vehicle to remain stationary on the street or portion thereof to which the device relates, in contravention of the device.

- (b) Where a traffic control device is placed or maintained to limit the period of time during which vehicles may be parked or stopped on the street or any portion thereof, no person shall stop or park a vehicle or cause or permit a vehicle to remain stationary on the street or portion thereof to which the device relates for a period longer than authorized by the device.
- (c) Except when necessary to comply with the law, or the directions of a peace officer, or traffic control device, no person shall stop, stand or park a vehicle within nine metres upon the approach to any flashing beacon, stop or arrêt sign or traffic control signal situated at the side of a roadway. amended 7580/2000 [Sec. 26 (a), (b), (c)]

RESIDENTIAL PARKING PERMITS

- 26.1 (1)Upon application to the Chief Operating Officer of the Winnipeg Parking Authority, and in accordance with the provisions of Schedule 10 hereof, a person may obtain a residential parking permit or Visitor's Residential Parking Permit. amended 205/2006
 - (2) Where a traffic control device is placed or maintained to prohibit parking except by permit or to limit the time during which vehicles may be parked on the street or any portion thereof, either during the whole of any day or during a part thereof a person may park a vehicle displaying a residential parking permit on a street specified in the residential parking permit, without restriction, during the period of time specified by the traffic control device.

LIMITED TIME PARKING AND DESIGNATED PARKING FOR PHYSICALLY DISABLED PERSONS amended 6007/92

27. Subject to Section 29, any vehicle, lawfully displaying a physically disabled person's parking permit issued pursuant to Section 124.3 of The Highway Traffic Act, C.C.S.M. c.H60, may be parked:

- for not more than four hours where and when parking is otherwise limited (a) by a traffic control device in the time during which vehicles may be parked on the street or portion thereof either during the whole of any day or during a part thereof;
- (b) where parking is designated for the use of the physically disabled by a traffic control device.

The provision of this section shall not relieve any person from the duty to observe other and more restrictive provisions, prohibiting the stopping or parking of vehicles. added 2318/79; amended 6007/92

PROHIBITION OF PARKING

28. No person shall park a vehicle on a street:

- (a) that is an alley;
- (b) in a loading zone except temporarily, whether the vehicle is occupied or not, for the purpose of, and while actually engaged in, loading or unloading. amended 2643/80

BOULEVARDS

28.1 No person shall drive a vehicle onto or along a boulevard or park or stop a vehicle on a boulevard.

added 1723/77

OVERNIGHT PARKING PROVISIONS

OVERNIGHT PARKING PROHIBITION ON STREETS BEARING "SNOW ROUTE" SIGNS

29. No person shall stop, stand or park a vehicle on a street bearing signs of the type specified and approved by Order No. 21/78 of the Highway Traffic Board (hereinafter referred to as "Snow Route" signs) between the hours of 02:00 and 06:00 of any day during the months of December, January and February.

amended 6288/93

PARKING PROHIBITIONS ON MAJOR SNOW ROUTES

29.1 (1) Where reasonably required in order to facilitate the removal of snow from streets bearing snow route signs, the Director may make a declaration prohibit standing, stopping or parking a vehicle between the hours of 00:00 and 06:00 on streets bearing a snow route sign for a period of time specified in the declaration. *amended 86/2005*

- (2) Where the prohibition referred to in Subsection (1) is declared, the Director shall make, or cause to be made, a record of the time and date of such declaration, and forthwith file a "Declaration of Implementation of Parking Prohibition on Snow Routes" at the Office of the City Clerk, Main Floor, Council Building, 510 Main Street, Winnipeg and inform the general public by issuing for immediate release, a communiqué to the media specifying the period during which the prohibition is in effect.
 - added 6288/93
- (3) No person may stand, stop or park a vehicle on a street bearing a snow route sign where a declaration made under subsection (1) is in effect. *added 86/2005*

PARKING PROHIBITION TO FACILITATE SNOW REMOVAL OPERATIONS ON STREETS NOT BEARING "SNOW REMOVAL" SIGNS

- 29.2 (1) No person shall stop, stand or park a vehicle on a street not bearing "Snow Route" signs between the hours of 00:00 and 6:00 of any day where such stopping, standing or parking has been declared by the Director to be prohibited.
 - (2) Where the prohibition referred to in Subsection (1) is declared, the Director shall make, or cause to be made, a record of the time and date of such declaration, and forthwith file a "Declaration of Implementation of Parking Prohibition on Residential Streets" at the Office of the City Clerk, Main Floor, Council Building, 510 Main Street, Winnipeg and inform the general public by issuing for immediate release, a communiqué to the media specifying the period during which the prohibition is in effect.

TRUCK, TRUCK TRACTOR, TRAILER, MOTOR HOME OR BUS PARKING LIMITED TO ONE HOUR

- 30. No person shall park
 - (i) a truck;
 - (ii) a truck tractor;
 - (iii) a trailer;
 - (iv) a motor home; or
 - (v) a bus, having more than 4 tires;

on a street for a period of time longer than one hour unless the vehicle in question is parked for use by a tradesman working on premises in the immediate area. *amended 3954/85*

PARKING ON ONE SIDE OF RESIDENTIAL STREETS

- 31. (1) No person shall park a vehicle at any time upon the east side of a street extending in a north/south direction or on the south side of a street extending in and east/west direction, where there exists a single roadway of 12 metres in width or less excepting when otherwise required or authorized by other provisions in respect of particular streets or portions of streets. amended 2169/78
 - (2) No person shall park a vehicle at any time upon the inner or shortest side of the roadway in any bay where there exists a single road of 12 metres or less in width, excepting when otherwise required by other provisions in respect of particular streets or portions of streets. *amended 2169/78*

PARKING EXEMPTIONS

32. The provisions of this by-law prohibiting or regulating stopping and parking shall not apply to:

- (a) vehicles of the Police Department of the City of Winnipeg;
- (b) vehicles of or employed by the City of Winnipeg while in use in connection with work of necessity being done in or near a highway requiring them to stop or be parked in contravention of any such provisions; and
- (c) vehicles of the Government of Manitoba, the Government of Canada, or a public utility if such vehicles have the owner's name painted thereon and are actually engaged in work of necessity on or near a highway requiring them to stop or be parked in contravention of any such provisions.

PARKING PROHIBITION TO ACCOMMODATE STREET WORK

33. (1) Except when otherwise directed by a peace officer, no person shall park or leave unattended a vehicle on any portion of a street between the hours of 10:00 p.m. and 7:00 a.m. of the following day or between the hours of 9:00 a.m. and 5:00 p.m. of any day, when signs have been erected indicating that street work is underway or is to be commenced at the time first indicated on the sign.

- (a) by 4:00 p.m. on the day that the said street work is to commence when work is to be carried out between 10:00 p.m. and 7:00 a.m. of the following day, or
- (b) after 5:00 p.m. and prior to 9:00 p.m. on the day before, when work is to be carried out between 9:00 a.m. and 5:00 p.m. of the following day. *amended 3972/85; 4427/86*

REMOVAL OF VEHICLES TO ACCOMMODATE SNOW REMOVAL OR STREET MAINTENANCE

34. The Director may move or cause to be moved a vehicle on a street that is stopped or parked in a position that causes it to interfere with removal of snow from the street or maintenance of the street.

ADVERTISING VEHICLES PROHIBITED FROM STOPPING

35. No person shall stop or park on a street an advertising vehicle, a vehicle displayed for sale, or a vehicle for the purpose of displaying goods, wares, or merchandise; provided however, a sign advertising a garage sale may be attached to a vehicle or placed in a window of a vehicle, legally parked on the street, on the day of the sale, the dimensions of which shall not exceed .5 metres vertical and 1.0 metres horizontal.

FUNERAL PROCESSIONS

36. The driver of every vehicle in a funeral procession indicated as such by the headlamps of all motor vehicles therein being lighted upon approaching a traffic control signal showing a red traffic control light, or a stop sign, shall cause the vehicle to slow down or stop as may be necessary for safety, but may then proceed cautiously past the traffic control signal or stop sign, the driver of each of the other vehicles in the procession shall have the right-of-way over all other vehicles upon the highway at the intersection or place where the signal or stop sign is situated.

TRAFFIC SIGNS AT A PRIVATE APPROACH

37. Where a traffic sign bearing the words "Entrance Only" or "Exit Only" or words to the same effect or restricting or regulating the mode of entrance to or exit from a private approach is erected at or near an approach, the driver of every vehicle shall obey the direction on any such traffic sign.

VEHICLES TO KEEP TO THE RIGHT

37.1 On a street which consists of more than one roadway separated by one or more dividing strips or boulevards, the driver of a vehicle shall keep to the right of the main or median dividing strip or boulevard.

LANE DIRECTION CONTROL SIGNALS

- 38. (1) Where a Lane Direction Control Signal showing a red "X" is located over a traffic lane, a driver of a vehicle facing the signal shall not drive or continue to drive in the traffic lane over which the Lane Direction Control Signal is located.
 - (2) Where a Lane Direction Control Signal showing a downward pointing green arrow is located over a traffic lane, the driver of a vehicle facing the signal may drive or continue to drive in the traffic lane over which the Lane Direction Control Signal is located.

ROUTE OF TRUCK TRAVEL

39. All trucks, truck tractors or combinations of either one of them with a trailer or trailers within The City of Winnipeg shall be operated only over and along the streets or sections of streets set forth as Truck Routes in Schedules 1 and 2 hereto, but any truck or truck tractor or combination of either one of them with a trailer or trailers may operate upon any street where necessary to the conduct of business at a destination point, provided that Truck Routes are used until reaching the intersection nearest the destination point. Upon leaving the destination point, a truck or truck tractor or combination of either one of them with a trailer or trailer or trailers truck a truck or truck tractor or combination of either one of them with a trailer or trailer or trailers shall return by the shortest routing to a Truck Route.

39.1 Notwithstanding Section 39, to minimize truck travel on non-truck routes when a truck or truck tractor or combination of either one of them with a trailer or trailers has multiple deliveries in an area bounded by Truck Routes, it may proceed to conduct such business without returning to the nearest Truck Route and only after the completion of all business return by the shortest routing to a Truck Route.

40. All streets and sections of streets set forth as Truck Routes in Schedule 1 hereto shall be further identified as Truck Routes by appropriate Truck Route signs except where Sections 42 and 43 apply, and shall remain open as Truck Routes, Monday to Sunday, both days inclusive, at all times.

41. All streets and sections of streets set forth as Truck Routes in Schedule 2 hereto shall be further identified as Truck Routes by appropriate Truck Route signs and shall remain open as Truck Routes, Monday to Saturday, both days inclusive, between the hours of 7:00 a.m. and 7:00 p.m.

42. Where "Route" Signs are installed and maintained on a street or section of street, the street or section of street shall be deemed to be a Truck Route within the terms of this by-law. amended 7142/98

43. Where Provincial Trunk Highway signs or Provincial Road signs of The Province of Manitoba are installed and maintained on a street or section of street, the street or section of street shall be deemed to be a Truck Route within the terms of this by-law.

44. The Director shall keep and maintain a current map setting out the streets and sections of streets set forth as Truck Routes in Schedules 1 and 2 hereto, and shall make available to the public, copies of the map at no charge.

VEHICLE WEIGHT AND LENGTH LIMITS

45. No person shall drive or move, or permit or cause to be driven or moved on any streets or sections of streets, a truck or truck tractor or combination of either one of them with a trailer or trailers, or any vehicle when the gross vehicle weight or the gross weight of the steering axle, single axle, axle group, the tire weight or the total length thereof is in excess of that applicable thereto as set out in Schedule 3 hereto, for an RTAC truck and Schedule 4 hereto for a truck other than an RTAC truck.

46. Notwithstanding Section 45 hereof, a person may drive or move, or permit or cause to be driven or moved on any streets or portions of streets a truck other than an RTAC truck or truck tractor or combination of either one of them with a trailer or trailers where a limit or limits set out in Schedule 4 hereto are exceeded, provided that:

- (b) the gross vehicle weight, or the weight of the steering axle, single axle, axle group, or the tire weight thereof is not in excess of that set out in that part of Schedule 5 hereto, applicable thereto; and
- (c) the total vehicle length thereof is not in excess of that set out in that part of Schedule 5 hereto, applicable thereto; and
- (d) upon leaving a point of origin within the City, the vehicle proceeds to the nearest junction of a Truck Route with Provincial Trunk Highway 100, Provincial Trunk Highway 101, and/or Lagimodiere Boulevard, also commonly known as Highway 59 and Route 20, whichever be the nearest, and follows the shortest route to that junction subject to Section 39 hereto; or
- (e) upon approaching the City, Provincial Trunk Highway 100, Provincial Trunk Highway 101, and/or Lagimodiere Boulevard, also commonly known as Highway 59 and Route 20, are used until reaching the junction with a Truck Route nearest the driver transfer point, if so required, or otherwise the destination point within the City, and thereafter the vehicle follows the shortest routing to the destination point subject to Section 39 hereto. *amended 7607/2000*

WEIGHT RESTRICTIONS OR ALLOWANCES ON SPECIFIC STREETS, WATERWAY CROSSINGS AND OVERPASSES

47. Notwithstanding the provisions respecting routes of truck and truck tractor travel within The City of Winnipeg contained in this By-law, the specific provisions of Schedules 6, 7 and 8 hereto shall govern the use of streets or portions of streets and the waterway crossings and overpasses set forth therein.

EMERGENCY VEHICLES

48. Notwithstanding the provisions respecting routes of truck and truck tractor travel within The City of Winnipeg contained in this by-law, an emergency vehicle in excess of the limits set out in this by-law may be operated upon all streets, waterway crossings and overpasses save and except for those waterway crossings and overpasses listed in Schedule 7 hereto.

SPECIAL PERMITS FOR OVERSIZED OR OVERWEIGHT VEHICLES

- 48.1 (1) Notwithstanding sections 45, 46, 47 and 48, the Director may issue a special permit permitting the operation of an oversized or overweight vehicle on streets within the City of Winnipeg where the Director is satisfied that the operation of the vehicle will not
 - (a) damage the streets over which it passes;
 - (b) disrupt traffic or pose a threat to vehicular traffic or pedestrians;
 - (c) damage properties adjacent to the right of way.
 - (2) A special permit issued under subsection (1) may be issued subject to conditions and limitations imposed by the Director to eliminate or minimize
 - (a) damage to the streets over which the vehicle will pass;
 - (b) disruption of traffic or the threat to vehicular traffic or pedestrians;
 - (c) damage to properties adjacent to the right of way.
 - (3) A special permit referred to in subsection (1) may not be issued prior to the payment of a fee set out in Schedule 11. amended 86/2005; 25/2007

AGE OF DRIVER OF A HORSE DRAWN VEHICLE

49. No person under the age of 16 years shall ride a horse or drive a horse drawn vehicle upon any street or portion of street.

HORSES AND HORSE DRAWN VEHICLES PROHIBITED ON CERTAIN STREETS

50. Between the hours 7:00 - 9:00 a.m. and 15:30 - 17:30 p.m. on any day excepting Saturdays, Sundays and Public Holidays, the riding of horses and the driving of horse drawn vehicles is prohibited on Regional Streets.

RIDING OF HORSES PROHIBITED IN DARKNESS

51. The riding of horses on streets during the hours of darkness is prohibited except on streets lit by street lights.

TIME

52. A reference to time shall be deemed to be a reference to Daylight Saving Time when such is in current use in the City of Winnipeg and at all other times to Central Standard Time applicable to the City of Winnipeg.

PENALTY

- 53. (1) Every person found guilty of a breach of any provision of this by-law, unless a penalty or fine is specifically provided therefor, shall be liable to a fine not exceeding \$1,000.00 in the case of an individual, or not exceeding \$5,000.00 in the case of a corporation, in addition to costs.
 - (2) Every person found guilty of a breach of Section 39 of this by-law shall be liable to a minimum fine of \$150.00. amended 6556/95
 - (3) Every person found guilty of a breach of any provision of Sections 17, 45, 46, 47 or 48 of this by-law shall be liable
 - (A) to a fine of not less or more than \$10.00 for each fifty kilogram, or fraction thereof, by which the actual gross weight of the vehicle or axle assembly exceeds the maximum gross weight prescribed in the appropriate schedule thereto, in addition to costs.
 - (B) where the fine computed under Clause (A)
 - (a) is, on a first offence, less than \$100.00 to a fine of not less than \$100.00 in addition to costs, and
 - (b) is, on a second offence, less than \$200.00, to a fine of not less than \$200.00 in addition to costs, and
 - (c) is, on a third or subsequent offence, less than \$500.00, to a fine of not less than \$500.00 in addition to costs. amended 3622/83 (entire Sec. 53)

LIABILITY OF OWNERS TO CONVICTION

- 53.1 Where an offence, consisting of a violation of any provision of this by-law
 - (a) is committed by means of, or with respect to any vehicle; or
 - (b) occurs by reason of, or with respect to, the ownership, use, or operation of any vehicle;

the owner of the vehicle may be charged with commission of the offence and, if the judge or justice before whom the charge is tried, is satisfied that the offence was committed, the owner is guilty of the offence and is liable, on summary conviction, to the penalty herein provided for that offence unless the owner satisfies the judge or justice that, at the time of the violation, the vehicle was in the possession of a person other than the owner or the driver without the consent of the owner.

LIABILITY OF DRIVER

53.2 Nothing in Section 53.1 relieves the driver of the vehicle from any liability to conviction of the offence to which he may be subject. *added 1723/77; amended 3622/83*

VOLUNTARY PAYMENT

54. Where it is alleged by a peace officer or by any person appointed to enforce this By-law, that any person has contravened a provision of this By-law, that person, on being notified of the allegation may voluntarily consent to pay the penalty for the contravention fixed by and in accordance with the procedure and to such person as is stated in the By-law of the City to permit the voluntary payment of penalties out of court for contravention of By-laws of the City respecting parking and traffic.

55. When payment has been made as provided in Section 54, there shall be no prosecution for the contravention in respect of which payment has been made.

APPEALS

55.1 An appeal from an order to remedy a contravention of this By-law or a decision made under this By-law may be made in accordance with *The City of Winnipeg Charter* to the Standing Policy Committee on Public Works.¹

SERVICE OF DOCUMENTS

55.2 Where an address for sending a notice, order, decision or other document is required, one of the following shall be used:

- (a) if the person to be served is the owner of real property, the address maintained by the tax collector for the purpose of issuing the tax notice for that property; and
- (b) if the person to be served is the occupant of real property, the street address for that property; and
- (c) if the document to be served relates to a permit, licence or other document for which the person to be served has applied, the address provided by the person in the application.² added 8162/2002

REPEAL

- 56. (1) All by-laws and by-law amendments, passed prior hereto by any area municipality as defined in clause (1) of Section 1 of *The City of Winnipeg Act* and still in force, relating to the regulation of traffic shall hereinafter cease to have effect, save as provided in (c) of Subsection 2 hereof.

MAXIMUM WEIGHTS AND LENGTHS OF RTAC TRUCKS UP TO 62,500 KILOGRAMS GVW, ALL MOVEMENTS, PURSUANT TO SECTION 45 OF THE TRAFFIC BY-LAW

- (a) Maximum gross weight of any RTAC truck or combination of RTAC truck 62,500 kilograms and the truck shall conform to that specified in Sections 28 of Manitoba Regulation 575/88 of *The Highway Traffic Act* (hereinafter referred to as "the Regulation"). For the purposes of this Schedule, the specifications pertaining to an RTAC Route class of highway as shown in Schedule H of the Regulation are applicable with respect to the application of Section 28 of the Regulation.
- (b) Axle Units:
 - (i) Maximum gross weight of any steering axle, 7,300 kilograms, with the exception of a truck tractor which shall be limited to 5,500 kilograms; subject to the minimum interaxle spacings specified in Schedules D of the Regulation.
 - (ii) Maximum gross weight of any single axle, 9,100 kilograms, except for the period commencing December 1 in any year and ending on the last day of February of the following year during which time the maximum gross weight of any single axle is increased by 10%; subject to the minimum interaxle spacings specified in Schedule D of the Regulation.
 - (iii) Maximum gross weight of any axle group as specified for an RTAC Route class of highway as shown in Schedule H of the Regulation, except for the period commencing December 1 in any year and ending on the last day of February of the following year during which time the maximum gross weight of any axle group is increased by 10%; subject to the minimum interaxle spacings specified in Schedule D of the Regulation.
 - (iv) Maximum gross weight of any steering axle or axle unit for each millimetre width of tire on the wheels of that steering axle or axle unit, 10 kilograms.
- (c) the truck length shall conform to that specified in Section 13 of the Regulation.

RESIDENTIAL PARKING PERMITS AND VISITOR'S RESIDENTIAL PARKING PERMITS

A. <u>Eligibility</u>

1. Subject to the provisions of this schedule, the Chief Operating Officer of the Winnipeg Parking Authority may issue an annual Residential Parking Permit for any vehicle registered in the name of a person whose residence fronts on a street

- (a) not referred to in Schedule E of the Streets By-law;
- (b) described in subsection 26.1(2); and
- (b) on which parking is not prohibited during specific periods of the day.

2. The Chief Operating Officer may not issue a Residential Parking Permit for a vehicle that weighs more than 3700 kilograms.

3. A person whose vehicle qualifies for a Residential Parking Permit under No. 1 may apply for a Visitor's Residential Parking Permit for a period of up to 30 days for a vehicle that is being used by a person residing temporarily at the residence.

4. A Visitor's Residential Parking Permit may be issued by the Chief Operating Officer where:

- (a) allowing an additional vehicle to be parked on the street would not unduly inconvenience or adversely affect residents;
- (b) the Chief Operating Officer is satisfied that the Visitor's Residential Parking Permit will in fact be used by a person residing temporarily at the residence.

5. Where the Chief Operating Officer cannot issue a Visitor's Residential Parking Permit because allowing an additional vehicle to be parked on the street would unduly inconvenience or adversely affect residents, he or she may issue a Visitor's Residential Parking Permit for that vehicle to be parked on an nearby street where allowing an additional vehicle to be parked on the street would not unduly inconvenience or adversely affect residents.

Schedule 10 (continued)

B. Application Procedure

1. In order to obtain a Residential Parking Permit, the applicant must provide to the Chief Operating Officer of the Winnipeg Parking Authority:

- (a) a copy of the vehicle registration; and
- (b) evidence that the vehicle qualifies for a permit;
- (c) an annual permit fee in the amount of \$25.00.

2. In order to obtain a Visitor's Residential Parking Permit, the applicant must provide to the Chief Operating Officer of the Winnipeg Parking Authority:

- (a) the licence plate number of the vehicle that requires the Visitor's Residential Parking Permit;
- (b) evidence that the applicant qualifies for a Residential Parking Permit; and
- (c) evidence that the person for whom the permit is sought will be temporarily residing at the residence.

C. Fine for failing to display permit

1. Where a Residential Parking Permit or a Visitor's Residential Parking Permit has been issued for a vehicle but is not displayed so that it is clearly visible from outside the vehicle, the person who applied for the permit is guilty of an offence and is liable, upon summary conviction, to a fine set out in the Voluntary Payment of Fines By-law.
